- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

THE AUCTION RATE SECURITY POSITIONS WERE IN THE CLIENTS ACCOUNT PRIOR TO BEING RANDOMLY ASSIGNED TO THE FINANCIAL ADVISOR. THE CLIENT HAD ONLY AUCTION RATE SECURITIES IN HIS ACCOUNT AND CONTINUED TO CALL TO SEE WHAT WAS AVAILABLE. THE CLIENT PRESENTED HIMSELF AS A VERY SOPHISTICATED INVESTOR AND WAS NOT INTERESTED IN ANY RECOMMENDATIONS. FINANCIAL ADVISOR'S ONLY FUNCTION FOR THIS CLIENT WAS TO LET HIM KNOW WHAT AUCTION RATE SECURITIES WERE AVAILABLE, FINANCIAL ADVISOR DID NOT SOLICIT THE PURCHASES. THE CLIENT SUFFERED NO LOSSES. THE FINANCIAL ADVISOR AND HIS TEAM MADE MANY ATTEMPTS TO MEET WITH THE CLIENT TO LEARN HIS OBJECTIVES AND GOALS, WHICH THE CLIENT WAS NOT INTERESTED. PRIOR TO THE AUCTION FAILURES AND ILLIQUIDITY, THE FINANCIAL ADVISOR REQUESTED TO LOCAL MANAGEMENT THAT THE ACCOUNT BE REASSIGNED AS THE CLIENT HAD NO INTEREST IN DEVELOPING A RELATIONSHIP WITH THE FINANCIAL ADVISOR AND HIS WEALTH MANAGEMENT TEAM.
