BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

CLIENT ALSO STATES HE WITHDREW \$100,000 AND THE FA WAS TO MOVE AN ADDITIONAL \$35,000 INTO THE MONEY MARKET. CLIENT INDICATES HE WAS INFORMED THIS MONEY COULD BE MOVED BACK IN THE FUNDS AT ANYTIME AT NO CHARGE. **Broker Statement**

ACCORDING TO FA, AT THE TIME CLIENT SOLD THE MUTUAL FUNDS, HE TALKED TO HIM ABOUT THE PROCEEDS, WHICH HE HAD WANTED TO PUT IN A CERTIFICATE OF DEPOSIT AT THE BANK. FA OFFERED OUR TAX-FREE MONEY MARKET AS AN ALTERNATIVE. IT WAS THE FA'S UNDERSTANDING THAT THE CLIENT DID NOT WANT TO RE-ENTER THE MARKET UNTIL THE DOW APPROACHED THE 3,000 TO 5,000 POINT LEVEL. FA ALSO STATES THAT COMMISSIONS WERE DISCUSSED ON MORE THAN ONE OCCASION WITH THE CLIENT. IN ADDITION, THE FA INDICATES THAT THE REINSTATEMENT OPTION WAS DISCUSSED; HOWEVER, CLIENT WAS OUTSIDE THE 90-DAY LIMIT TO TAKE ADVANTAGE OF IT WHEN HE DECIDED TO RE-ENTER THE MARKET IN FEBRUARY 2009. WE WERE UNABLE TO DETERMINE WHAT FACTS TO WHICH THE CLIENT WAS REFERRING WHEN HE MENTIONED THE CHECK TAKING ELEVEN DAYS TO REACH HIM. WITHOUT KNOWING MORE FACTS FROM THE CLIENT, WE WERE NOT ABLE TO COMMENT ON THAT PART OF THE CLIENT'S LETTER.

Allegations: THE CLIENTS STATE THEY TRANSFERRED THEIR FUNDS FROM ANOTHER FIRM TO EDJ BECAUSE THE PREVIOUS FIRM WAS CHURNING THEIR ACCOUNT. THE CLIENTS STATE THEIR ACCOUNT VALUE WAS \$221,343 WHEN THEY TRANSFERRED INTO EDJ AND HAS GONE DOWN TO \$214,451. THE CLIENTS ARE NOT HAPPY WITH THE PERFORMANCE OF THE STOCKS OSING HAS RECOMMENDED AND STATE THEY ARE MORE COMFORTABLE WITH MUNIS, CDS AND MUTUAL FUNDS.
