**Broker Statement**

This was a predatory loan with an interest rate of 462.83%. I took this out when I was unemployed with no unemployment benefits to pay my COBRA medical insurance premium. As I fell behind in my payments due to being unemployed in a pandemic with no benefits, I chose to settle with AWL since I had no intention of ever being a front facing producing registered rep for a broker dealer. I settled for \$644. I paid them \$2,738.39 (which was more than double what I borrowed.)
