#### What is included in a BrokerCheck report?

  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.

In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?

FLOWERS MADE UNSUITABLE RECOMMENDATIONS TO A CUSTOMER IN LIGHT OF THE CUSTOMER'S INVESTMENT OBJECTIVE, FINANCIAL NEEDS AND RISK TOLERANCE; ATTEMPTED TO SETTLE AWAY COMPLAINTS WITHOUT THE KNOWLEDGE OR CONSENT OF HIS EMPLOYING MEMBER FIRM; AND COMMUNICATED WITH CUSTOMERS VIA UNAPPROVED, OUTSIDE EMAIL ACCOUNTS WITHOUT HIS MEMBER FIRMS' KNOWLEDGE OF CONSENT. AS A RESULT OF HIS OUTSIDE COMMUNICATIONS, HIS MEMBER FIRMS WERE UNABLE TO REVIEW HIS EMAILS TO FIRM CUSTOMERS. FLOWERS ALSO
