BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

IR STATED HE WAS CONTACTED BY CLIENT AND HER ATTORNEY IN 2001 FOR THE PURPOSE OF PURCHASING A LIFE INSURANCE POLICY. IR INDICATED CLIENT WANTED TO ENSURE HER CHILDREN WOULD BE LEFT WITH SOMETHING IN THE EVENT OF HER DEATH AS CLIENT WAS IN THE PROCESS OF A DIVORCE. IR STATED THE AMOUNT OF COVERAGE WAS SET AFTER DETERMINING CLIENT'S NET WORTH WITH BOTH CLIENT AND HER ATTORNEY. IR INDICATED CLIENT WAS INFORMED IR COULD OBTAIN AN INITIAL QUOTE BUT FIRM QUOTE COULD NOT BE PROVIDED UNTIL AFTER A PHYSICAL AND MEDICAL HISTORY WAS REVIEWED. IR FURTHER INDICATED CLIENT WAS AWARE THIS WAS A VARIABLE POLICY AND THE FUND INVESTMENTS WITHIN THE POLICY WERE NOT GUARANTEED. ACCORDING TO IR, CLIENT WAS ADDITIONALLY INFORMED THE LENGTH OF TIME TO PAY THE PREMIUM WOULD DEPEND ON HOW WELL FUNDS PERFORMED. IR DISCUSSED ALL CHARGES AND FEES INCLUDING POTENTIAL SURRENDER PENALTIES. DUE TO HEALTH ISSUES, CLIENT RECEIVED LOWER RATING AND PREMIUM WAS SET AT A HIGHER AMOUNT. NEW ENGLAND FINANCIAL NOTIFIED CLIENT OF THIS ON AUGUST 8, 2001, AND NEW ILLUSTRATION WAS PROVIDED. THE AMENDMENT TO APPLICATION FOR INSURANCE REFLECTING HIGHER PREMIUM WAS EXECUTED BY CLIENT ON AUGUST 7, 2001, AND CLIENT ACKNOWLEDGED RECEIPT OF THE POLICY CONTRACTS ON SAME DATE. BASED ON OUR REVIEW, IT WOULD APPEAR CLIENT WAS MADE AWARE OF FEATURES OF THE POLICY AND AMOUNT OF POLICY WAS DETERMINED BASED ON INFORMATION PROVIDED BY CLIENT AND HER ATTORNEY. ADDITIONALLY, IT APPEARS CLIENT WAS MADE AWARE, BASED ON THE RATING, OF THE HIGHER PREMIUM AND CLIENT ACCEPTED THE AMOUNT REFLECTED BY SIGNATURE OF AUGUST 7, 2001. FURTHER, ACCORDING TO THE IR, CLIENT'S ATTORNEY WAS PRESENT DURING CONVERSATIONS REGARDING TERMS OF THE POLICY. CLAIM DENIED.
