FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

 - An "adjudicated" matter includes a disposition by (1) a court of law in a criminal or civil matter, or (2) an administrative panel in an action brought by a regulator that is contested by the party charged with some alleged wrongdoing.
 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

Allegations:	<p>The firm initiated an internal review following information received from the supervising branch manager indicating that Mr. Geraigery may have provided client-related information and other proprietary firm materials to a former advisor of the firm. According to the branch manager's report and related email correspondence, the information may have been used to assist the former advisor in contacting, attracting, maintaining, or servicing clients through the advisor's new firm.</p> <p>Such conduct, if confirmed, would constitute a violation of firm policies, including the firm's Code of Ethics and policies regarding the protection of confidential client information and proprietary materials, as well as the representative's duty of loyalty to the firm.</p> <p>The firm terminated Mr. Geraigery's association while the review was ongoing. The internal review is continuing to determine the scope of the conduct, including the nature of any client information or proprietary materials that may have been shared, the extent of any communications with the former advisor, and whether any applicable securities laws or regulatory rules may have been implicated.</p>
