BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and

CLIENTS ALLEGE THAT I MADE UNAUTHORIZED TRADES IN THEIR ACCOUNTS AS WELL AS DISPUTING THE ASSET-BASED FEES CHARGED FOR THEIR ACCOUNTS. I VEHEMENTLY DENY BOTH ALLEGATIONS AND SUBSTANTIAL WRITTEN DOCUMENTATION EXISTS VERIFYING CLIENTS APPROVED ALL OF THE TRADES MADE IN THEIR ACCOUNTS AS WELL AS THE FEE STRUCTURE AGREED UPON FOR THEIR ACCOUNTS. THE MAJORITY OF THE TRADES IN QUESTION OCCURRED BETWEEN JULY THROUGH SEPTEMBER OF 1999 AND SIX ADDITIONAL TRADES OCCURRED IN DECEMBER, 1999. THE ALLEGATIONS BEGAN IN MARCH, 2000. PRIOR TO THESE ALLEGATIONS, THE RELATIONSHIP WITH CLIENTS WAS VERY POSITIVE. WHEN THE ALLEGATIONS BEGAN, THE CLIENTS CLAIMED THAT





ALL TRADES MADE IN THEIR ACCOUNTS WERE UNAUTHORIZED  
ALTHOUGH I HAD CONDUCTED SEVERAL COMPLETE PORTFOLIO REVIEWS
