- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

I AM ANSWERING YES TO 14I(3)A DESPITE THE FACT THAT THERE WERE NOT DAMAGES OF \$5,000 OR GREATER. AS FAR AS THE COMPLAINT, MS. DUERKSEN BECAME A CLIENT OF MINE THROUGH A "BROKER OF THE DAY" CALL. SHE WAS UNHAPPY WITH THE BROKER SHE ALREADY HAD AT MORGAN STANLEY DW AND WANTED TO SWITCH TO SOMEONE NEW. SHE EVEN MENTIONED THAT SHE WANTED TO SUE HIM AND EXPLAINED THE CIRCUMSTANCES. I TOLD HER THAT HER REASONS WERE UNFOUNDED FOR A LAWSUIT, BUT IF SHE WAS UNHAPPY, I WOULD HANDLE HER ACCOUNTS FOR HER. AFTER DISCUSSING HER OBJECTIVES, WE PUT THE MONEY IN MUTUAL FUNDS. AT SOME POINT (THIS WAS ALL DOCUMENTED, BUT I LOST EVERYTHING IN THE WORLD TRADE CENTER ON 9/11/01), SHE TOLD ME THAT SHE WANTED TO BE MORE AGGRESSIVE, SO WE MADE CHANGES IN HER ACCOUNT. THERE WERE A FEW INSTANCES WHERE SHE CALLED IN AND WANTED TO SELL HER FUNDS AND BUY FIXED INCOME. I EXPLAINED THE CONCEPT OF LONG-TERM INVESTING AS IT APPLIED TO HER OBJECTIVES, AS MORGAN STANLEY TRAINED US TO, AND ASKED THAT SHE NOT SELL HER EQUITY FUNDS. SHE AGREED EACH TIME. WHEN THE MARKET WOULD GO UP TEMPORARILY, SHE WAS HAPPY. WHEN IT WENT DOWN, I WOULD HAVE TO DISCUSS LONG-TERM INVESTING AGAIN. AFTER THIS OCCURRED AGAIN AND AGAIN, I FINALLY TOLD HER THAT IF SHE ABSOLUTELY WANTED TO SELL HER FUNDS, I WOULD SELL HER FUNDS. SHE SAID THAT SHE DID WANT TO, AND I DID, AGAINST MY BETTER JUDGEMENT, AS I NOTED IN MY RECORDS. I NOTED



TIME AND TIME AGAIN THAT MS. DUERKSEN WAS A POTENTIAL PROBLEM, AS SHE MADE SNAP JUDGEMENTS AND WOULD LET HER EMOTIONS GET THE BETTER OF HER. MORGAN STANLEY DENIED THE CLAIM AND I FEEL THAT EVERYTHING I DID WAS IN HER BEST INTEREST. OBVIOUSLY, BY ATTEMPTING TO GET HER TO HOLD HER FUNDS AND NOT SELL THEM TO BUY OTHERS, I WAS DENYING MYSELF COMMISSIONS.
