FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations:	FINRA RULE 2010 NASD RULE 2110: CAMPBELL CONVERTED APPROXIMATELY \$35,000 FROM A CHURCH WHERE CAMPBELL ACTED AS A VOLUNTEER TREASURER AND A MEMBER OF THE CHURCH'S BOARD OF TRUSTEES. CAMPBELL CONVERTED THE FUNDS FROM THE CHURCH BY TAKING PRE-SIGNED CHECKS AND MAKING THEM PAYABLE TO HIM. CAMPBELL DEPOSITED THESE CHECKS INTO HIS PERSONAL BANK ACCOUNT AND USED THE FUNDS FOR PERSONAL EXPENSES. ALSO, ON A FREQUENT BASIS, CAMPBELL TOOK FOR HIS PERSONAL USE AND BENEFIT, SOME OF THE CASH RECEIVED FROM THE CHURCH'S COLLECTIONS. ADDITIONALLY, ON AT LEAST ONE OCCASION, CAMPBELL FORGED THE SIGNATURE OF THE CHURCH'S VICE PRESIDENT ON A CHECK THAT CAMPBELL MADE PAYABLE TO HIMSELF AND INTENDED TO USE FOR PERSONAL EXPENSES. CAMPBELL DEPOSITED THE CHECK INTO HIS BANK ACCOUNT. CAMPBELL CONFESSED HIS MISCONDUCTS TO THE CHURCH. CAMPBELL WAS ARRESTED AND CHARGED WITH GRAND LARCENY IN THE THIRD DEGREE AND CRIMINAL POSSESSION OF A FORGED INSTRUMENT IN THE SECOND DEGREE. CAMPBELL PLED GUILTY TO GRAND LARCENY IN THE THIRD DEGREE.
