FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement	I deny the allegations by Merrill in their entirety. The issue at hand stems from immediate family member's account that I am a co-owner, signatory of, and have full power of attorney. When the issue came to light this family member



told my former branch manager directly that the firm was mistaken and that there is zero issue to be concerned with.
When questioned by Merrill I was honest and did not conceal any information. I've been in the business for over 21 years (all with Merrill) I have zero client complaints and zero regulatory matters. I contend that the issue that caused my discharge was an attempt to damage my reputation in an effort by Merrill to damage me by taking or retaining my book of clients and not paying me deferred comp and other monies owed to me. I'm aware of other advisors that this happened to.
