- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ALSO, FA CONFIRMS HE MET WITH THE CUSTOMER THREE TIMES AND HE DISCUSSED THAT THE ANNUITY WOULD FLUCTUATE IN VALUE. FA FURTHER STATES CUSTOMER'S DAUGHTER WAS PRESENT DURING ONE OF THE MEETINGS AND CONFIRMS CUSTOMER UNDERSTOOD PRODUCT AND AUTHORIZED ITS PURCHASE. THE COMPLAINT IS DENIED.

THE CLIENT SIGNED A DISCLOSURE STATING THAT THE PRINCIPAL IS NOT GUARANTEED. THEREFORE ALL OF HER ALLEGATIONS ARE FALSE. THE CLIENT HAS NOT REALIZED ANY LOSSES AT THIS TIME AND AS OF 5/20/2008 THE ACCOUNT VALUE IS \$197,000. SEVERAL ATTEMPTS HAVE BEEN MADE TO CONTACT THE CLIENT AND SHE HAS NOT RESPONDED.
