- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

I SPOKE WITH HER ABOUT THE DEGREES OF RISK & VOLATILITY ASSOCIATED WITHIN DIFFERENT ASSET CLASSES OF STOCKS, AS WELL AS INTEREST RATE RISK & DURATIONS ASSOCIATED WITH BONDS. WE ALSO SPOKE IN DETAIL ABOUT HER INVESTMENT OBJECTIVE, RISK TOLERANCE, & TIME HORIZON. I VERBALLY GAVE HER THE "NOT FDIC INSURED" DISCLOSURES BOTH OVER THE PHONE & AT OUR APPOINTMENT, AS WELL AS INFORMED HER THAT I WORK AS A DUAL EMPLOYEE OF WELLS FARGO BANK & WELLS FARGO INVESTMENTS. I HAD/HAVE THE "NOT FDIC INSURED" DISCLOSURE POSTED IN MY DESK AREA, ALONG WITH THE SIPC SIGN & NYSE POSTER. SHE ALSO RECEIVED & SIGNED THE CLIENT ACCOUNT AGREEMENT (WHICH STATES THE "NOT FDIC INSURED" DISCLOSURES AGAIN) AS WELL AS SHE SIGNED THE MF SHARE CLASS AND BREAKPOINT FORMS. ADDITIONALLY, DURING OUR APPOINTMENT SHE RECEIVED THE PROSPECTUS' AND FACT SHEETS FOR THE 2 MUTUAL FUNDS SHE INVESTED IN, AS WELL AS MY WFI BUSINESS CARD (WHICH ALSO HAS "NOT FDIC INSURED" DISCLOSURES ON IT). ON 5/19/04, SHE FAXED A COMPLAINT LETTER TO WFI, CLAIMING THAT I REPRESENTED MYSELF AS A BANKER. PRIOR TO 5/19/04, SHE HAD RECEIVED INVESTMENT CONFIRMATION NOTICES (IN MARCH), AS WELL AS MONTHLY STATEMENTS FOR MARCH AND APRIL. UNDER NO UNCERTAIN TERMS DID I EVER MISLEAD ANDREA INTO THINKING THE INVESTMENTS I OFFERED WERE FDIC INSURED OR THAT I WAS A BANKER. SHE KNEW EXACTLY WHAT MY ROLE WAS AT WFI, & KNEW THE RISKS ASSOCIATED WITH THE INVESTMENTS SHE CHOSE. I INTEND TO VIGOROUSLY DEFEND MYSELF AGAINST ANDREA'S FALSE ACCUSATIONS.
