BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. THE FA HAS INDICATED AND ACCOUNT RECORDS SUPPORT THAT THE CLIENT CONTACTED HIM ON 1/26/10 WITH CONCERNS ABOUT A LETTER SHE HAD RECEIVED FROM METLIFE REGARDING HER RMD. AN APPOINTMENT WAS ESTABLISHED FOR 1/28/10. DURING THE MEETING, THE FA REVIEWED THE CLIENT'S ACCOUNTS WITH HER AND A RISK TOLERANCE QUESTIONNAIRE WAS COMPLETED. BASED ON THE RESULTS OF THE QUESTIONNAIRE AND THE CLIENT'S DISCUSSION WITH THE FA, IT SEEMS THE CLIENT HAD CONCERNS ABOUT MARKET VOLATILITY AND DESIRED STABLE INCOME. THE FA HAS INDICATED HIS DISCUSSIONS WITH THE CLIENT REGARDING THE INVESTMENTS INCLUDED COMMISSIONS AND HOW THEY ARE APPLIED. IN REGARD TO THE INCOME PROVIDED BY THE INVESTMENTS, OUR RECORDS REFLECT (PRIOR TO THE CHANGES MADE IN JANUARY 2010) SHE HAD BEEN REMOVING APPROXIMATELY \$4,680.00 PER ANNUM AND IT APPEARS THE JP MORGAN CHASE NOTES PURCHASED IN THE IRA ACCOUNT WILL PROVIDE APPROXIMATELY \$214.37 PER MONTH AND THE JP MORGAN CHASE NOTES PURCHASED IN THE SINGLE REGISTRATION ACCOUNT WILL PROVIDE APPROXIMATELY \$109.38 IN INCOME. IN ADDITION, THE WITHDRAWAL FROM THE ABOVE REFERENCED ANNUITY WAS (ACCORDING TO METLIFE) INCREASED TO THE MAXIMUM ALLOWED UNDER THE INCOME RIDER.. AT THE TIME OF THE TRANSACTIONS, THE CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS. IN ADDITION, ALL OF THE AFOREMENTIONED ACTIVITY HAS BEEN REFLECTED ON ACCOUNT STATEMENTS. THEREFORE, IT APPEARS THE TRANSACTIONS EFFECTED IN THE ACCOUNT WERE COMPLETED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. BASED ON OUR REVIEW, IT APPEARS THE JP MORGAN CHASE NOTES WILL MEET THE CLIENT'S GOAL OF RECEIVING A STEADY INCOME FROM THE INVESTMENTS HELD IN HER ACCOUNT(S). HOWEVER, WE HAVE OFFERED TO REIMBURSE THE CLIENT FOR ANY LOSSES INCURRED SHOULD SHE ELECT TO SELL THE NOTES. AS OF 7/27/10, NO SIGNED SETTLEMENT OF CLAIM HAS BEEN RECEIVED. COMPLAINT CLOSED.
