- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

Broker Statement

Northwestern Mutual determined that Exley's recommendations were suitable and were in alignment with the customer's financial goals and investment profile. Northwestern Mutual also identified an operational error that adversely impacted the execution of the recommendations. As such, Northwestern Mutual decided to pay the customer an amount that could be reasonably associated as having resulted from that error.

The Firm completed its investigation into this matter and found that the trades that occurred were in alignment with the customer's stated risk tolerance and long-term goals. The customer had signed documents agreeing to the transfer of funds,



including the stock in question. The Firm determined that the sale of the stock was part of the customer's overall investment portfolio to which the customer had agreed. Based on the information the Firm reviewed, the customer's allegations were found to be without merit and her request to be reimbursed for her tax liability was denied.
