BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Allegations: 01/15/2008-03/27/2009; THE CLIENT STATED THAT THE FA ASSISTED HIM IN LIQUIDATING AN ANNUITY THAT WAS HELD IN A QUALIFIED PLAN WITH AN INSURANCE COMPANY. WHEN THE FUNDS WERE RECEIVED BY OUR FIRM THEY WERE DEPOSITED INTO A PERSONAL ACCOUNT, RATHER THAN AN IRA ACCOUNT. THE CLIENT ADDED AN ADDITIONAL \$26,000.00 TO THE ORIGINAL AMOUNT WHEN THESE FUNDS WERE RECEIVED. THE CLIENT IS NOW HAS TO PAY TAXES ON THE FUNDS THAT WERE NOT ROLLED OVER TO AN IRA PLAN FROM THE ANNUITY. SINCE THE CLIENT FELT THAT THE FA SHOULD HAVE ADVISED HIM TO ROLL THESE FUNDS INTO AN IRA, HE NOW FEELS THAT THE FA AND/OR EDWARD JONES SHOULD REIMBURSE HIM FOR THE \$17,776 IN TAXES THAT HE OWES.

THE FA STATED THAT THE NEW YORK LIFE ANNUITY WAS NOT SURRENDERED THROUGH HIS OFFICE. SEVERAL WEEKS LATER, WHEN THE CLIENT BROUGHT THE CHECK TO THE FA'S OFFICE HE ADDED ANOTHER CHECK OF APPROXIMATELY \$25,000.00 TO THE ANNUITY AMOUNT AND DIRECTED HIM TO DEPOSIT THESE FUNDS INTO THE JOINT PERSONAL ACCOUNT. THE FA SET THIS ACCOUNT UP WITH A SYSTEMATIC WITHDRAWAL OF \$650.00 PER MONTH. SINCE THE CLIENT RECEIVED DEPOSIT RECEIPTS FOR THE CHECKS AND MONTHLY ACCOUNT STATEMENTS SHOWING WHERE AND HOW THESE FUNDS WERE INVESTED, THE CLIENT'S CLAIM FOR REIMBURSEMENT ON HIS TAX BILL WAS DENIED.
