BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

Broker Statement	In April and March of 2022, I exchanged a portion of a few of my clients from growth funds to commodity-based funds. LPL questioned me about it and contacted some of my clients for verification of correspondence. There were two clients they contacted in August and asked them if they remembered talking to me

about these exchanges. Both of these clients are in their late 70's and they replied that they didn't remember talking to me since so much time had passed. I had spoken to both of them in March regarding these transactions and when I called them after the allegations were brought up, they did remember speaking to me. Both of these transactions were exchanges made within the same fund family with no commission generated. In my response to LPL, I stated these facts. One week after I sent them my response, I received a phone call from LPL informing me that I was discharged. I was stunned and shocked and asked if they followed up with these two clients to verify these allegations and they replied that they tried calling them but got their voicemail and that they did not speak to either one of them. So NO, they did not verify these allegations. They stated that because I am an independent contractor, they reserve the right to terminate me at any time. The accusations are not true and were not even followed up on which leads me to believe LPL is shedding reps for whatever reasons they have. It is not right or fair to have these allegations now on my permanent record.
