## About BrokerCheck®



BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. **Allegations:** 3/24/08-9/25/08; CLIENT STATES ON MARCH 24, 2008 SHE HAD A DISCUSSION WITH THE FA ABOUT HER CONCERNs RELATING TO THE MARKET. CLIENT EXPRESSED TO THE FA THAT SHE MAY HAVE TO DRAW ON THESE FUNDS SINCE THE REAL ESTATE MARKET IS UNSTABLE AND SHE IS A REALTOR. CLIENT CLAIMS SHE ASKED FA HOW TO KEEP HER FUNDS SAFE AND THE FA RECOMMENDED TO STAY IN THE INVESTMENTS AND NOT TO PANIC. CLIENT STATES THE STOCK MARKET CONTINUED TO DECLINE AND ON SEPTEMBER 25, 2008 SHE WANTED OUT. CLIENT INDICATES THE FA OFFERED TO MOVE HER MUTUAL FUNDS TO THE MONEY MARKET MUTUAL FUND. CLIENT IS QUESTIONING WHY THIS OPTION WAS NOT OFFERED TO HER SOONER AND SHE FEELS THAT THE FA'S RECOMMENDATION COST HER \$20,000.

<b>Broker Statement</b>	<p>IT DOES APPEAR THE CLIENT HAS OWNED THE MUTUAL FUNDS IN QUESTION IN HIS ACCOUNT FOR SEVERAL YEARS. THESE MUTUAL FUNDS DO NOT APPEAR TO BE UNSUITABLE INVESTMENTS FOR THE CLIENT BASED ON THE STATED ACCOUNT OBJECTIVES. WHILE THE CLIENT HAS CLAIMED THAT THE FA TOLD HIM THE FUNDS IN HIS SEP ACCOUNT WERE "VERY CONSERVATIVE," THE FA HAS STATED THAT HE NEVER USED THAT PHRASE IN RELATION TO THESE INVESTMENTS. INSTEAD, THE FA HAS STATED THAT IN HIS DISCUSSIONS WITH THE CLIENT ABOUT THIS ACCOUNT HE DESCRIBED THESE INVESTMENTS AS WELL-BALANCED, WELL-MANAGED AND OF GOOD QUALITY, HISTORICALLY CARRYING LESS MARKET RISK THAN FUNDS CATEGORIZED AS GROWTH OR AGGRESSIVE GROWTH. FURTHERMORE, IT WOULD APPEAR THAT IF THE FA WAS SOLELY CONCERNED ABOUT GENERATING A COMMISSION IN RELATION TO THE CLIENT'S PORTFOLIO, HE WOULD HAVE ENCOURAGED THE CLIENT TO SELL THESE MUTUAL FUNDS IN ORDER TO PURCHASE OTHER INVESTMENTS. WHILE WE UNDERSTAND CLIENT'S DISAPPOINTMENT IN THE PERFORMANCE OF HIS ACCOUNT, WE HAVE BEEN EXPERIENCING TUMULTUOUS MARKET CONDITIONS OVER THE LAST YEAR AND MARKET FLUCTUATION IS A RISK ASSOCIATED WITH OWNING ANY INVESTMENT. AS A RESULT OF OUR REVIEW, WE MUST RESPECTFULLY DENY ANY REQUEST FOR REIMBURSEMENT OF MARKET LOSSES ASSOCIATED WITH THE INVESTMENTS HELD IN THE CLIENT'S ACCOUNT.</p>
