BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: 1/10-2/11; CLIENT STATES SHE HAD AN ACCOUNT THAT WAS TRANSFERRED TO HER CURRENT FA. CLIENT STATES SHE WAS CONTACTED BY FA AND THEY MET IN EARLY APRIL 2010. DURING THAT MEETING CLIENT ALLEGES THAT FA STATED SHE NEEDED TO GET INTO MORE CONSERVATIVE FUNDS AND ADVISED HER THERE WAS NO UP FRONT CHARGE JUST A SMALL MONTHLY FEE. CLIENT STATES HE SOLD HER MUTUAL FUNDS AT A LOSS OF \$64,175.92 AND PUT THEM INTO A MANAGED ACCOUNT. CLIENT STATES THE FA DID NOT INFORM HER THERE WOULD BE A LOSS OR SHE WOULD NOT HAVE AGREED TO MAKE THE CHANGE. CLIENT IS QUESTIONING WHY FA DID NOT JUST EXCHANGE HER EXISTING FUNDS TO MORE CONSERVATIVE FUNDS IN THE SAME FUND FAMILY. CLIENT IS REQUESTING \$93,420.99. ARBITRATION: CLAIMANT ALLEGES FA IMPROPERLY PLACED HER IN UNSUITABLE SECURITIES. CLAIMANT ALLEGES THAT FA CONVINCED HER TO SELL HER PRIOR SECURITIES AND PURCHASE NEW UNSUITABLE SECURITIES IN THE FEE BASED ADVISORY SOLUTIONS, WHICH SHE CLAIMS MADE HER INCUR UNFORESEEN FEES AND COSTS. CLAIMANT SEEKS RESCISSION OF SALE AND PURCHASE OF SECURITIES IN HER ACCOUNTS.

OUR INVESTIGATION REVEALED THE FA DID A RISK TOLERANCE QUESTIONNAIRE FOR THE CLIENT DURING THEIR 2010 ANNUAL REVIEW. THE ANSWERS THE CLIENT PROVIDED INDICATED THE CLIENT NEEDED TO BE IN A CONSERVATIVE TAX EFFICIENT PORTFOLIO. THE FA DISCUSSED REALLOCATING WITHIN THE AMERICAN FUNDS FAMILY AND THE ADVISORY SOLUTIONS PROGRAM. THE CLIENT PREFERRED THE ADVISORY SOLUTIONS PROGRAM SO SHE WOULD NOT HAVE TO BE INVOLVED IN CONTINUAL REALLOCATION DECISIONS. OUR REVIEW FURTHER



INDICATES THE CLIENT AND FA HAD A DETAILED DISCUSSION REGARDING THE CHARGES, COMMISSIONS, AND FEES, AS THE FA EXTENDED, AND THE CLIENT ACCEPTED, A 15% DISCOUNT FROM THE FA FOR THE PROGRAM. ACCORDING TO THE FA HE FURTHER DISCUSSED THE CLIENT WOULD CAPTURE A LOSS; HOWEVER, THE REASON FOR THE MOVE WAS TO ALIGN WITH THE CLIENTS STATED RISK TOLERANCE, NOT TO TIME THE MARKET. BASED ON OUR INVESTIGATION WE BELIEVE THE CLIENT MADE THE DECISION TO MOVE TO ADVISORY SOLUTIONS WITH FULL DISCLOSURE, KNOWLEDGE, AND UNDERSTANDING OF THE PROGRAM; THEREFORE, HER REQUEST FOR REIMBURSEMENT RELATED TO THIS MATTER IS DENIED. ARBITRATION SETTLED FOR \$57,500.
