- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

IT IS OUR UNDERSTANDING THE LEHMAN BROTHERS AND CIT GROUP WERE PURCHASED TO HELP PROVIDE INCOME IN THE ACCOUNTS. YOU HAVE STATED YOU BELIEVED THE BONDS WERE SECURE. AT THE TIME OF THE PURCHASE, THE BONDS WERE INVESTMENT GRADE. OUR RECORDS INDICATE YOU RECEIVED INTEREST ON THE CIT GROUP UNTIL THE BOND WAS LIQUIDATED. THE LEHMAN BROTHERS BOND PAID INTEREST TO YOU THROUGH THE JUNE 2008. THE FA RECOMMENDED LIQUIDATING THE CIT GROUP BASED ON INFORMATION PROVIDED BY OUR FIXED INCOME DEPARTMENT. IT IS OUR UNDERSTANDING YOU AGREED TO LIQUIDATE A PORTION IN JULY 2009 AND THE REMAINING IN NOVEMBER 2009. CLIENT STATES SHE HAS A COMPLAINT REGARDING HER RECENT ROLLOVER. CLIENT STATES SHE WAS NOT ADVISED HER TOTAL COMMISSION COULD BE REDUCED BY MEETING BREAKPOINTS. CLIENT INDICATES SHE WAS CHARGED AT THE \$100,000 BREAKPOINT AND SHE COULD HAVE MET THE \$250,000 WITH LORD ABBETT FUNDS IF IT WAS DISCLOSED, WHICH WOULD HAVE REDUCED HER COMMISSION 1.2%. ADDITIONALLY, AT THE TIME OF THE PURCHASES, THE CLIENT WOULD HAVE RECEIVED THE APPROPRIATE PROSPECTUS WHICH OUTLINES THE FEES. FA HAS STATED HE AGAIN MET WITH THE CLIENT IN LATE JANUARY AND CONTENDS THE CLIENT DID NOT BRING UP THESE CONCERNS AND THAT THE DISCUSSION WAS BASED ON THE MARKET CONDITION.
