BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

THIS CLIENT WAS AN EXPERIENCED INVESTOR WHOSE ACCOUNTS STATED PRIMARY AND EXCLUSIVE GOAL WAS TO BE AGGRESSIVE AND SPECULATIVE AS NOTED ON THE ACCOUNTS OFFICIAL STATEMENT. THE CLIENT ALLEGES THAT THE USAGE OF MARGIN WAS NOT EXPLAINED. THAT IS ENTIRELY FALSE. THE ACCOUNT HAD TRANSFERRED IN WITH A MARGIN DEBIT BALANCE. THE ALLEGATION THAT THE ACCOUNT WOULD BE BILLED A FLAT RATE OF \$750 FOR TRADING IN THE ACCOUNT IS INACCURATE AND UNTRUE. THE ACCOUNT WAS SET UP AND STRUCTURED AS AN ACCOUNT THAT WOULD BE BILLED AT 3/4 OF 1% OR 75 BASIS POINTS ON THE TOTAL VALUE OF THE ACCOUNT AS WAS UNDERSTOOD BY THE CLIENT AND ONLY POSSIBLE THROUGH SIGNED AUTHORIZATION BY THE CLIENT. THIS FEE AGREEMENT WAS ALSO DULY



NOTED ON ALL OFFICAL ACCOUNT STATEMENTS. LASTLY, THE CLIENT'S ALLEGATION THAT FUNDS WERE TRANSFERRED WITHOUT PERMISSION IS ABSOLUTELY FALSE. THE TRANSFER OF MONIES AND SECURITIES IS NOT POSSIBLE WITHOUT THE SIGNED AUTHORIZATION OF THE CLIENT AND FURTHER ENFORCED WITH A SIGNATURE GUARANTEE OF THE FIRM THAT THE FUNDS WERE TRANSFERRED TO. THIS IS CALLED THE ACAT PROCESS.
