BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. PRICES OR SPECIFIC DATES; HOWEVER, IN REVIEWING ACCOUNT INFORMATION, IT APPEARS CLIENT IS MOST LIKELY REFERRING TO THE SHARES OF DELL COMPUTER CORP (DELL) WHICH WERE HELD IN THE CLIENT'S ACCOUNT. THE IR STATED THAT HE DID NOT RECALL CLIENT SPECIFYING A PRICE AT WHICH TO SELL DELL. HAD SUCH AN ORDER BEEN ENTERED, CLIENT WOULD HAVE RECEIVED A TRADE CONFIRMATION REFLECTING AN OPEN ORDER. SINCE THE INSTRUCTIONS WERE PURPORTEDLY PROVIDED TO IR, CLIENT WOULD HAVE RECEIVED STATEMENTS WHICH PROVIDE INFORMATION REGARDING THE INVESTMENTS HELD IN THE ACCOUNT AS WELL AS REFLECTING ACCOUNT ACTIVITY. IN REVIEWING ACCOUNT INFORMATION, THERE HAVE BEEN NUMEROUS BUYS AND/OR SELLS INVOLVING DELL IN THE ACCOUNT SINCE MID-2000 AND IT APPEARS THE POSITION WAS LIQUIDATED IN FULL IN JULY, 2001. BASED ON OUR REVIEW, IT IS OUR OPINION THAT THE IR DID NOT RECEIVE INSTRUCTIONS FROM THE CLIENT TO PLACE A STOP ORDER FOR DELL. CLAIM DENIED.
