- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

LIEN IS ERRONEOUS. I OWE NO, "ZERO" MONEY TO THE IRS FOR BAX TAXES OR ANYTHING ELSE. IRS SENT ME NOTICE OF APPROXIMATE \$15,000 UNDERPAYMENT OF TAX LIABILITY RELATED TO \$75,000 IRA CONVERSION IN 2001. TAX LAW CHANGED 2 WEEKS BEFORE I CONVERTED REQUIRING PAYMENT IN ONE YEAR RATHER THAN OVER FOUR YEARS. I HAD CONSULTED IRS DIRECTLY PRIOR TO CONVERSION BUT WAS MISINFORMED; NEVERTHELESS, I PAID FULL AMOUNT OF TAX LIABILITY - IN FACT OVERPAID LIABILITY BY SEVERAL THOUSAND DOLLARS SOON AFTER NOTIFICATION. I CONTACTED IRS SEVERAL YEARS AGO AND WORKED WITH AGENT IN PA BY PHONE TO RECOUP EXCESS TAXES PAID. AGENT'S LAST WORDS WERE "YOU WILL RECEIVE EXCESS PAID PLUS INTEREST BUT THIS IS THE IRS AND WE COMMIT TO NO TIMETABLE". SINCE I HAD NOT BEEN REFUNDED I KNEW MATTER WAS NOT RESOLVED, AT LEAST ADMINISTRATIVELY, BUT I'D NEVER RECEIVED ANY NOTICE OF A LIEN FILING. I WILL WORK TO REENGAGE THE IRS AND/OR IF NECESSARY, ADDITIONAL ASSISTANCE TO FORCE IT TO CORRECT THE MATTER AND CANCEL THE SECURITY INTEREST IN MY PROPERTY.
