FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Allegations:

[CUSTOMER] COMPLAINED TO PRIOR BROKER/DEALER AFTER VALUE OF HIS MUTUAL FUNDS DECLINED, ALLEGING THAT HE DID NOT UNDERSTAND RISKS ASSOCIATED WITH MUTUAL FUND INVESTMENTS. CUSTOMER HAD PRIOR INVESTMENT EXPERIENCE IN STOCKS AND BONDS, AND BEFORE HE INVESTED, I HAD FULL AND COMPLETE CONVERSATIONS WITH CUSTOMER ABOUT ASSOCIATED RISKS OF MUTUAL FUND INVESTMENTS, INCLUDING MARKET FLUCTUATION AND POSSIBLE LOSS OF PRINCIPAL. I ALSO PROVIDED CUSTOMER WITH PROSPECTUS FOR EACH FUND BEFORE HE INVESTED. BROKER/DEALER RESOLVED COMPLAINT WITH CUSTOMER MONETARILY, WITHOUT FIRST INFORMING ME THAT THERE HAD BEEN A WRITTEN COMPLAINT, WITHOUT REQUESTING ANY INFORMATION OR RESPONSE FROM ME, AND WITHOUT FULLY INVESTIGATING THE CUSTOMER'S ALLEGATIONS. NASD ALSO INQUIRED INTO THIS MATTER, AND CLOSED ITS INQUIRY WITH NO ACTION TAKEN AFTER FINDING THAT NO SALES PRACTICE VIOLATION HAD OCCURRED. [CUSTOMER] HAD PURCHASED THE MUTUAL FUNDS IN MID TO LATE 1999 WITH ME AS HIS REPRESENTATIVE IN GLENDALE, CA. IN DECEMBER OF 1999, I ACCEPTED A TRANSFER TO THE NORTHERN CALIFORNIA OFFICES OF CAL FED INVESTMENTS. FROM JANUARY OF 2000 TO APRIL OF 2001, ANOTHER REPRESENTATIVE HANDLED [CUSTOMER] ACCOUNT. YET, CAL FED INVESTMENTS ERRONEOUSLY MARKED MY U-5 FOR 100% OF THE CUSTOMER ACCOMMODATION SETTLEMENT OF \$34,000.00 WHICH REPRESENTS THE MARKET FLUCTUATION OF HIS ACCOUNT UP UNTIL THE DATE HIS ACCOUNT WAS LIQUIDATED IN APRIL 2001 WHEN I ONLY ADVISED HIM ON HIS ACCOUNT FOR LESS THAN 6 MONTHS IN 1999.
