FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

ACCORDING TO OUR RECORDS, VARIOUS AMERICAN FUNDS WERE PURCHASED IN THE ACCOUNT FEBRUARY 2005. ACCORDING TO THE FA, THE CLIENT DID CONTACT HIM DURING THE MARKET DECLINE WITH YOUR CONCERNS RELATED TO MARKET CONDITIONS. THE FA HAS INDICATED HE EXPLAINED THE CLIENT'S PORTFOLIO WAS COMPRISED OF QUALITY INVESTMENTS AND HE BELIEVED THE VALUES OF THE INVESTMENTS WOULD RECOVER WITH THE MARKET. THE FA HAS STATED HE MET WITH THE CLIENT IN FEBRUARY 2009 AT WHICH TIME THE CLIENT INFORMED HIM THAT SHE COULD NO LONGER TOLERATE MARKET FLUCTUATION. IT IS UNDERSTOOD THE FA ENCOURAGED THE CLIENT TO REMAIN INVESTED, BUT DID SUGGEST THAT THE EXISTING FUNDS COULD BE EXCHANGED INTO A MONEY MARKET FUND UNTIL SHE WAS MORE COMFORTABLE WITH THE MARKET. HOWEVER, SHORTLY THEREAFTER, PAPERWORK WAS RECEIVED TO TRANSFER THE ACCOUNT TO WELLS FARGO. PURSUANT TO THE INSTRUCTIONS RECEIVED, THE INVESTMENTS HELD IN THE ACCOUNT WERE LIQUIDATED AND THE TRANSFER WAS COMPLETED. AT THE TIME OF THE PURCHASES, THE CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS AS WELL AS THE APPROPRIATE PROSPECTUSES. SINCE THE PURCHASES, THE CLIENT HAS RECEIVED STATEMENTS WHICH PROVIDE INFORMATION REGARDING THE INVESTMENTS HELD IN THE ACCOUNT AS WELL AS REFLECTING ACCOUNT ACTIVITY. EXPLAINED THE FIRM'S INVESTMENT PHILOSOPHY IS TO BUY AND HOLD QUALITY INVESTMENTS FOR THE LONG TERM; THEREFORE, WE DO NOT BELIEVE ENTERING AND EXITING THE MARKET ON A FREQUENT BASIS IS A PRUDENT INVESTMENT STRATEGY. BASED ON OUR REVIEW, IT IS OUR OPINION THE PURCHASES WERE COMPLETED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. IN ADDITION, IT DOES NOT APPEAR THE INVESTMENTS WERE OUTSIDE THE SCOPE OF THE ACCOUNT OBJECTIVES. FURTHERMORE, THE INVESTMENTS WERE LIQUIDATED AT THE CLIENT'S DIRECTION. CLAIM DENIED.
