BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. - **Are there other resources I can use to check the background of investment professionals?**

THE FA INDICATES HE WAS INFORMED BY THE CLIENT SHE WANTED TO RECEIVE 4-6% INCOME AND PROTECT THE PRINCIPLE OF THE INVESTMENTS. THE CLIENT HAD BONDS AND STOCKS AT PREVIOUS FIRM. AFTER SEVERAL MEETINGS, THE CLIENT INQUIRED ABOUT ANNUITIES. THE FA INDICATES HE REVIEWED THE DEATH BENEFITS, INCOME RIDERS, POTENTIAL MARKET FLUCTUATION AND COSTS OF ANNUITIES. HE ALSO REVIEWED THE DCA PROGRAM. THE FA STATES THE CLIENT REQUESTED INFORMATION ON PROTECTIVE AND HARTFORD. THE CLIENT DECIDED TO TRANSFER HER ACCOUNT, LIQUIDATE THE STOCKS AND KEEP THE BONDS. THE PROCEEDS FROM THE STOCK TRANSACTIONS WERE TRANSFERRED AS CASH AND INVESTED INTO PROTECTIVE AND HARTFORD ANNUITIES. THE CLIENT CONTINUED TO RECEIVE INCOME FROM THE BONDS AND WITHDREW THE PRINCIPLE OF THE BONDS AS THEY MATURED. THE CLIENT CONTACTED THE FA SEVERAL TIMES REGARDING THE VALUE OF THE BONDS AND ANNUITIES. SHE DECIDED TO LIQUIDATE ON NOVEMBER 3, 2008, BUT RELAYED THE MESSAGE THROUGH A THIRD PARTY. THE FA HAS ATTEMPTED TO CONTACT CLIENT TO CONFIRM INSTRUCTIONS, BUT HAS NOT BEEN ABLE TO SPEAK WITH THE CLIENT. BASED ON OUR REVIEW, IT APPEARS THE FA REVIEWED THE BENEFITS AND POTENTIAL RISKS OF THE ANNUITIES THE CLIENT PURCHASED. THE FA STATES HE WAS NOT AWARE THE CLIENT WANTED TO RETURN TO HER NATIVE COUNTRY WITHIN TWO YEARS. THE CLIENT'S REQUEST FOR REIMBURSEMENT OF THE PRINCIPLE AMOUNT INVESTED IN THE ANNUITIES IS RESPECTFULLY DENIED; THE CLIENT CAN LIQUIDATE AT CURRENT MARKET VALUE.
