BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

CLIENT STATES THAT WHEN SHE WOULD CALL THE IR IN RESPONSE TO CONFIRMS OR MARGIN CALLS, THE IR WOULD TELL HER EITHER THAT THE ACCOUNT WAS TOO HEAVY IN HEINZ AND THAT IR WANTED CLIENT TO BE MORE DIVERSIFIED, OR THAT IR WAS TRYING TO PAY OFF CLIENT'S LOAN FASTER. IR EXPLAINED IN DETAIL ALL OF THE MEETINGS AND DISCUSSIONS THAT WERE HAD WITH THE CLIENT REGARDING HER ACCOUNT AND SPECIFICALLY THE MARGIN CALLS AND STOCK THAT HAD TO BE SOLD TO MEET THE CALLS. THE IR STATED THAT HE DISCUSSED MARGIN WITH THE CLIENT AND HOW MARGIN CALLS WORK; THAT STOCK WOULD HAVE TO BE SOLD TO SATISFY THE CALL IF THE CLIENT DID NOT SEND IN FUNDS TO COVER IT. IR ALSO STATED THAT HE CONTACTED THE CLIENT EACH TIME THERE WAS A CALL AND THAT IR'S BRANCH OFFICE ADMINISTRATOR CONTACTED THE CLIENT WHEN A WARNING NOTICE WAS RECEIVED PRIOR TO THE CALL. IT APPEARS AS THOUGH THE IR MADE THE CLIENT AWARE OF THE MARGIN CALLS AND MADE A RECOMMENDATION ON WHICH STOCK TO SELL IN THE EVENT OF A CALL AND THAT THE CLIENT WAS AWARE THAT THE SHARES WERE BEING SOLD TO MEET THE CALLS. THE IR HAS STATED THAT HE CAUTIONED THE CLIENT ABOUT WITHDRAWING TOO MUCH MONEY BEFORE THE MARGIN CALLS BEGAN HAPPENING. CLAIM DENIED.

THE OTHER STOP ORDERS THAT WERE METIONED WERE ALL PLACED AFTER THE CLIENT AGREED TO THE PRICES. THESE WERE NEVER EXECUTED BECAUSE THE MARKET NEVER REACHED THE PRICES SET BY THE CLIENT. IT WAS DETERMINED THAT THE STOP ORDERS WERE PLACED CORRECTLY. CLAIM DENIED.
