BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. ACCORDING TO IR HE MADE AN INITIAL PROPOSAL TO CLIENT IN MAY 1999; HOWEVER, A REVISED PROPOSAL WAS DISCUSSED IN NOVEMBER 1999. WHEN IR RECEIVED THE ROLLOVER CHECK, IR CONTACTED THE CLINET TO CONFIRM THE FUNDS TO BE PURCHASED (BASED ON THE NOVEMBER MEETING) AND CLIENT AUTHORIZED THE TRANSACTIONS. IR INDICATED THE BRANCH CONTACTED THE CLIENT BY MAIL AND TELEPHONE DURING THE TIME CLIENT'S ACCOUNT WAS AT EJ; HOWEVER, CLIENT WAS UNRESPONSIVE TO MANY OF THE CONTACTS. IN REGARD TO CLIENT'S DISCUSSION WITH THE IR IN OCTOBER 2005 (RELATED TO THE FREE SWITCH), IR INDICATED FOUR AMERICAN FUNDS WERE DISCUSSED. IR STATED IT WAS HIS OPINION CAPITAL INCOME BUILDER WAS THE LEAST RISKY OF THE FUNDS DISCUSSED AND CLIENT AGREED TO MAKE THE SWITCH. IR INDICATED AT NO TIME DID CLIENT REQUEST HER MONEY BE MOVED TO CASH OR A MONEY MARKET FUND. BASED ON OUR REVIEW, WE WILL NOT BE MAKING AN ADJUSTMENT TO CLIENT'S ACCOUNT. CLAIM DENIED.
