#### What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
  qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

#### **Broker Statement**

WHILE EMPLOYED BY BANYAN PARTNERS, LLC (BANYAN) FROM JUNE 2009 TO OCTOBER 2010, MR. PAYNE FURNISHED THE NECESSARY INFORMATION TO BANYAN AND IN GOOD FAITH BELIEVED THAT BANYAN HAD COMPLETED THE PROCESS TO REGISTER HIM IN FLORIDA AS AN INVESTMENT ADVISER REPRESENTATIVE. UNBEKNOWNST TO MR. PAYNE, BANYAN FAILED TO COMPLETE THE REGISTRATION PROCESS, AND MR. PAYNE WAS UNAWARE OF THE NON-COMPLIANCE UNTIL AFTER HE JOINED MORGAN STANLEY IN EARLY 2014. BANYAN'S ERROR RESULTED IN A FINDING BY OFR THAT MR. PAYNE CONDUCTED ADVISORY BUSINESS IN FLORIDA WHILE EMPLOYED BY BANYAN WITHOUT REGISTRATION. IN CONNECTION WITH THIS SETTLEMENT, OFR AGREED TO APPROVE MR. PAYNE'S APPLICATION AS AN INVESTMENT ADVISER REPRESENTATIVE IN FLORIDA.
