BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

WERE DIVERSIFICATION, CONSERVATIVE GROWTH, MONTHLY INCOME AND REGULAR CONTACT. ALTHOUGH THE HUSBAND EXPRESSED AN AVERSION TO MFDS, HE ASKED THAT THE CLIENTS ALLOW HIM THE OPPORTUNITY TO EXPLAIN WHY HE BELIEVED MFDS MAY BE A GOOD INVESTMENT TO ASSIST IN MEETING THEIR GOALS. THE FA MET WITH THE CLIENTS AGAIN ON 05/08 TO DISCUSS THEIR CURRENT PORTFOLIO. THE CLIENTS MET WITH FA ON 6/11/08 AT WHICH TIME HE RECOMMENDED A DIVERSIFIED PORTFOLIO INCLUDING CASH, BONDS, INDIVIDUAL STOCKS AND MFDS. THE FA HAS STATED HE PROVIDED THE CLIENTS WITH DETAILED INFORMATION REGARDING THE MFDS TO INCLUDE HYPOTHETICALS AND PROSPECTUSES. THE TRADES WERE PLACED ON 6/12/08 AND THE FA HAS FURTHER INDICATED HE MET WITH THE CLIENTS AGAIN ON 6/16/08 TO REVIEW THE TRADE CONFIRMATIONS. ACCORDING TO THE FA THE HUSBAND HAD REVIEWED THE ACCOUNT ON ACCOUNTLINK AND BELIEVED A PORTION OF THE FUNDS WERE NOT IN THE PORTFOLIO. THE FA EXPLAINED SOME THE BONDS HAD NOT PRICED. HE HAS INDICATED HE REVIEWED EACH AND EVERY TRANSACTION WITH THE CLIENTS AND BELIEVED THE CLIENTS WERE SATISFIED WITH THE RESULTS OF THEIR CONVERSATION. THE FA HAS INDICATED THE CLIENTS CONTACTED THE OFFICE ON 6/17/08, 6/19/08 AND 6/20/08 TO EXPRESS CONCERNS ABOUT THE VALUE OF THE INVESTMENTS PURCHASED IN THE ACCOUNT. THE FA HAS STATED HE EXPLAINED THE INVESTMENTS HAD BEEN HELD FOR A VERY SHORT TIME AND HE BELIEVED GIVEN TIME THE INVESTMENTS WOULD MEET THE CLIENTS OBJECTIVES. IT IS OUR OPINION THE TRANSACTIONS WERE COMPLETED WITH THE CLIENTS' KNOWLEDGE AND AUTHORIZATION. IT APPEARS THE FA MADE HIS RECOMMENDATIONS BASED ON HIS DISCUSSIONS WITH THE CLIENTS AND THEIR STATED INVESTMENT OBJECTIVES. BASED ON OUR REVIEW, WE WILL BE MAKING NO ADJUSTMENTS TO THE ACCOUNT. CLAIM DENIED.
