BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

I was not named as a Respondent in this arbitration, and I believe I committed no wrongdoing. The customer's allegations are completely without merit. First, the customer was a participant in an employee benefit plan and not the trustee of the plan that made the decision to invest in the product at issue. The Trustee never complained about the investments at issue. Second, the features, benefits, and all risks of recommended investments were fully discussed with and acknowledged by the trustee prior to purchase, which occurred well over a decade before the case was filed. The trustee received, read, and acknowledged suitability and understanding of the features, benefits, and all risks of recommended investments by signing applicable disclosure forms which detailed the potential for liquidity restrictions and the potential for investment losses. As I do with all customers, I believe I provided excellent, tailored service to the trustee. I believe the broker-dealer chose to settle for a nominal sum which was well under the cost of an arbitration hearing. I stand by my recommendations and the service I provided to both the trustee and the complaining customer. I made no monetary contribution to the settlement.
