BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Broker Statement I WAS THE BRANCH MANAGER OF A RETAIL BRANCH OF REGIONS BANK. ON 10/6/2010 A MAN CAME INTO THE BRANCH AND PROCEEDED TO THE TELLER. I WAS WORKING AS A TELLER AT THE DRIVE THRU AND OVERHEARD A CONVERSATION BETWEEN THE TELLER AND THE MAN. HE



STATED THAT HE WOULD LIKE TO MAKE A WITHDRAWAL FROM HIS ACCOUNT. THE TELLER DID NOT KNOW THE MAN AND SHE ASKED HIM FOR HIS DRIVERS LICENSE. HE FILLED OUT A COUNTER WITHDRAWAL SLIP FOR OVER \$8,000. THE DRIVER'S LICENSE MATCHED WHAT WE HAD FOR THE ACCOUNT. SINCE THE MAN IN FROM OF US WAS FROM TENNESSEE THE TELLER ASKED HIM WHAT BROUGHT HIM TO SOUTH CAROLINA. HE RESPONDED THAT HE WAS TRAVELING AND NEEDED SOME MONEY OUT OF HIS ACCOUNT. THE TELLER PROCEEDED TO PROCESS THE WITHDRAWAL SINCE THERE WAS NO TO SUSPECT HE WAS NOT WHO HE SAID HE WAS. BECAUSE THE AMOUNT OF THE WITHDRAWAL WAS OVER THE TELLERS CHECK CASHING LIMIT, SHE NEEDED A SUPERVISOR OVERRIDE, WHICH I PROVIDED. IT WAS LATER DISCOVERED THAT THE PERSON WHO CAME INTO OUR OFFICE HAS STOLEN OUR ACCOUNT HOLDERS IDENTITY. I WAS TERMINATED DUE TO THE FACT I APPROVED THE CHECK AND THE BANK LOST OVER \$8,0000 ON THE FRAUDULENT TRANSACTION.
