I finalized a Deed In Lieu of Foreclosure with my mortgage company for my Rental Property. I had been working with them all last year to work toward a resolution to avoid foreclosure. My renter had been delinquent on the rent for an extended period of time. This caused my mortgage to fall behind. After discussing alternatives with the mortgage company, we reached an agreement to complete the Deed In Lieu of foreclosure in which I turned the property over to the bank and they cleared the mortgage. The property was valued at more than my mortgage balance, so there was nothing that I had to pay out of pocket.
