- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Sanctions Ordered:	Other: License to practice law was reinstated on February 11, 2016 after a \$153.30 fee was paid consisting of the \$75.00 annual fee, a \$75.00 reinstatement fee, and a \$3.30 servicing fee. Practice Book Sections 2-70 and 2-79(A) provide that the license to practice law of an attorney who fails to pay the annual client security fund fee may be administratively suspended until such time as the fee, along with a reinstatement fee in the amount of \$75.00 is paid.
Broker Statement	Ms. Silva has been a member of the Connecticut Bar since December 1990. She has never practiced law in the state of Connecticut. She worked briefly as an attorney from 1990-1991, but has not practiced law since. She did not engage in the practice of law during the time of the administrative suspension. As an attorney to practice law in Connecticut, she was required to pay A \$75.00 annual fee for the Client Security Fund. She paid the amount due and her license was reinstated on February 11, 2016. There was no Disciplinary proceeding involved. In January 2017, she notified the Connecticut Bar of her intention to retire from the Connecticut Bar and permanently relinquished her Bar membership since she has never used it and does not plan to use it in the future.
