BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. In the alternative, you may search the IAPD website directly or contact your state securities regulator at <http://www.finra.org/Investors/ToolsCalculators/BrokerCheck/P455414>.

- **Are there other resources I can use to check the background of investment professionals?**

Allegations: THE CLIENTS CLAIM THAT WHEN THEY PURCHASED GE BONDS THEY WERE TOLD THAT THE FA DID NOT MAKE ANY MONEY FROM THE PURCHASE; THAT HIS COMMISSION WAS PAID BY GE. THE CLIENTS STATE THEY WERE TOLD BY THE FA THAT IF INTEREST RATES WENT DOWN THE VALUE OF THE BOND WOULD GO UP THEN IF THEY SOLD THEY WOULD GET FACE VALUE PLUS A PREMIUM. THE CLIENT ALSO STATE THEY WERE TOLD THAT IF GE WENT BANKRUPT THEY WOULD NOT LOSE A DIME BECAUSE GE WAS GLOBAL. THE CLIENTS STATED THEY HAVE FOUND THAT THESE THING ARE NOT TRUE AND ARE REQUESTING THEIR ORIGINAL INVESTMENT OF \$100,000 BACK. INVESTMENT HAS LOST IN EXCESS OF \$5,000 OF VALUE.

Broker Statement

FA CLAIMS THAT HE DID EXPLAIN TO CLIENTS HOW HE WOULD BE PAID ON SALE OF THE GE BOND, AS HE DOES WITH ALL OF HIS CLIENTS. CLIENTS WERE TOLD THAT TYPICALLY BOND PRICES INCREASED AS RATES DECREASED, BUT WITH UNUSUAL MARKET CONDITIONS AND ITEMS SPECIFIC TO GE, NOT NECESSARILY THE CASE CURRENTLY. BONDS STILL AAA RATED AND PAYING ANNUAL INCOME PER CLIENTS' DESIRE FOR INCOME. REVIEW OF CONTACT BETWEEN THE BRANCH AND CLIENTS SUBSEQUENT TO FILING OF COMPLAINT INDICATE THEY WANT TO KEEP THE BOND. FA CLAIMED THAT HE NEVER TOLD CLIENTS THAT THEY WOULD NOT LOSE MONEY IF GE WENT BANKRUPT. CLAIM DENIED.
