- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

Broker Statement

TWO ARBITRATORS AWARDED CLAIMANTS \$32,500.00 50% OF TEH ALLEGED LOSSES, AND NO PUNITIVE DAMAGES, ATTORNEY'S FEES, OR INTEREST. THE THIRD ARBITRATOR REFUSED TO GO ALONG WITH THE AWARD. HE DISSENTED AND WOULD NOT SIGN THE AWARD. THE BROKER DID NOT PARTICIPATE IN THE AWARD. AFTER MONTHS OF REVIEWING DIFFERENT INVESTMENTS, THE [CUSTOMERS] DECIDED TO INVEST A PORTION OF A \$420,000 PROFIT FROM A PAINWEBBER PRIVIATE PLACEMENT INTO TWO BOND FUNDS, THE [CUSTOMERS] OBJECTIVE OF RECEIVING A DEPENDABLE MONTHLY INCOME WAS BEING ACHIEVED, BUT THEY BECAME UNHAPPY WHEN THE PRICE OF THE SHARES WENT DOWN. PHILLIPS WAS COMPLETELY EXONERATED BY AN INTERANL INVESTIGATION AND NONE OF THE COSTS OF THE AWARD WERE PERSONALLY CHARGED TO HIM. ON A TOTAL RETURN BASIS, THE [CUSTOMERS] DID NOT SUSTAIN A LOSS. IN FACT, INCLUDING DIVIDENTDS, THEY REALIZED A NET GAIN OF \$35,559.36 WHEN THE FUNDS WERE SOLD FOR AN AVERAGE ANNUAL RETURN OF 3.25% PER YEAR.
