BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

IR HAS INDICATED THAT THE CLIENTS CAME TO HIM IN AUGUST OF 2004 INDICATING THEY HAD AN ANNUITY COMING DUE AND WERE INTERESTED IN INVESTING THE MONIES FROM THE ANNUITY IN A LONG-TERM, INCOME PRODUCING INVESTMENT. IT IS OUR UNDERSTANDING THAT AFTER REVIEWING THE BONDS WE HAD AVAILABLE, THE CLIENTS AND THE IR COLLECTIVELY DECIDED ON THE GMAC BOND. IR ALSO CONTENDS THE CLIENTS UNDERSTOOD THE BOND PRICE WOULD FLUCTUATE ACCORDING TO INTEREST RATES AND MARKET CONDITIONS AND ADDITIONALLY STATES HE DID NOT REPRESENT THE BOND AS A COMPLETELY SAFE. IN CLOSING WHEN THE ACCOUNT WAS BEING SERVICED BY A ST. LOUIS INVESTMENT REPRESENTATIVE, IT IS OUR UNDERSTANDING THERE WAS CONTACT WITH THE CLIENTS, HOWEVER, THE CLIENTS DID NOT INDICATE THAT THEY HAD ANY CONCERNS WITH THE INVESTMENT. ADDITIONALLY, DURING THAT TIME, THE CLIENTS WERE SENT MONTHLY STATEMENTS, WHICH REFLECTED THE VALUE OF THE INVESTMENT.
