BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

FA EXPLAINED THAT THE PURPOSE OF THE VARIABLE ANNUITY WAS TO CREATE A GUARANTEED INCOME STREAM AND POSSIBLE DEATH BENEFIT FOR BENEFICIARIES, WHICH WAS ALSO OUTLINED AS REASONS FOR PURCHASE ON THE 'VARIABLE ANNUITY PURCHASE IN A TAX QUALIFIED ACCOUNT' ACKNOWLEDGEMENT LETTER. THE ACCOUNT HISTORY DOES INDICATE REGULAR MONTHLY INCOME WITHDRAWALS FROM THE ANNUITY BEGINNING IN MARCH 2007. THE SECURITIES INVESTOR PROTECTION CORPORATION (SIPC) INSURES SECURITIES AND CASH IN CUSTOMER ACCOUNTS OF BANKRUPT BROKER/DEALERS, IT DOES NOT COVER AGAINST INVESTMENT LOSS. ANNUITY POLICY OWNER CLAIMS AND GUARANTEES ARE BACKED BY INDIVIDUAL LIFE INSURANCE COMPANIES, BOTH OF WHICH ARE REGULATED BY STATE INSURANCE DEPARTMENTS FOR THE BENEFIT OF POLICYHOLDERS. FA STATED THAT SALES CHARGES ASSOCIATED WITH THE VARIABLE ANNUITY PURCHASE WERE DISCLOSED DURING THE PRESENTATION MEETING WHILE DISCUSSING THE DOLLAR COST AVERAGING FEATURE. BASED ON THE CLIENT'S MUTUAL FUND HOLDINGS AT THE TIME OF THE ANNUITY PURCHASE, THE CLIENT QUALIFIED FOR SIGNIFICANTLY REDUCED SALES CHARGES. ADDITIONALLY, INFORMATION PROVIDED WITHIN THE REQUIRED PROSPECTUS AS WELL AS THE 'VARIABLE ANNUITY PURCHASE IN A TAX QUALIFIED ACCOUNT' OUTLINE THE SALES CHARGES ASSOCIATED WITH A SHARE PURCHASES.
