- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

I WAS PLACED ON ADMINISTRATIVE LEAVE ON JUNE 3, 2010 AND TERMINATED ON JUNE 11, 2010 FOR PURPORTEDLY "FAILING TO FOLLOW COMPANY POLICY REGARDING THE ACCURACY OF BOOKS AND RECORDS."

Broker Statement	I NOTE THAT AT NO TIME BEFORE, DURING, OR AFTER ANY INTERNAL REVIEW WAS I EVER ALLEGED THAT I HAD BEEN, NOR WAS I EVER ACCUSED OF, VIOLATING ANY STATUTE, REGULATION, OR INDUSTRY STANDARD OF CONDUCT. IN ADDITION, I HAVE DENIED AND CONTINUE TO



DENY THAT I FAILED TO FOLLOW ANY OF PERSHING'S POLICIES AND PROCEDURES WITH REGARD TO THE ACCURACY OF BOOKS AND RECORDS. MY CONDUCT WITH RESPECT TO THE EVENTS THAT GAVE RISE TO THE ABOVE-REFERENCED TRANSACTIONS WAS WITHIN PERSHING PRACTICES, POLICIES AND PROCEDURES. PERSHING WAS WELL AWARE OF THE LONGSTANDING AND COMMON BOOKKEEPING PRACTICES AND PROCEDURES IN ITS STOCK LOAN DEPARTMENT THAT WERE DEVELOPED BY PERSHING PERSONNEL TO (I) COMPENSATE FOR INEFFICIENCIES IN THE SYSTEMS UTILIZED BY STOCK LOAN PERSONNEL AND (II) UTILIZE ALL OF THE LENDABLE STOCK IN PERSHING'S INVENTORY THAT THE SECURITIES LAWS AND REGULATIONS PERMITTED. IN POINT OF CLARITY, GIVEN PERSHING WAS AWARE OF THESE PRACTICES AND PROCEDURES, I ALSO DISPUTE AND CONTINUE TO DISPUTE PERSHING'S ASSERTION THAT AN INTERNAL REVIEW OF STOCK LOAN PERSONNEL WAS CONDUCTED TO "REVEAL" WHETHER CERTAIN LOANS AND BORROWS RESULTED IN A POTENTIAL VIOLATION OF THE SECURITIES LAWS, REGULATION, OR INDUSTRY STANDARDS OF CONDUCT.
