- **What is included in a BrokerCheck report?**

BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and

**Broker Statement**

I wish to address a matter regarding a sale facilitated by one of the advisors in our firm. It is important to clarify that I was not directly involved in the sales process and had no prior knowledge of the client in question. The advisor, acting independently, designed and executed the sale in accordance with the client's wishes and under the guidance of the client's CPA. Subsequently, approximately one year after the sale, the client expressed a desire to retract the life insurance premium. Despite efforts to negotiate with the life insurance company for a return of the premium, the client's request was denied. Consequently, the client pursued further action by initiating a complaint process. Initially, the complaint was declined by the State of Hawaii, prompting the client to escalate the matter to FINRA, where it was ultimately resolved through arbitration. It is noteworthy that my name was not implicated in the final disposition of this matter. Nonetheless, I wish to affirm my full support for the advisor involved, who diligently and ethically served the client's interests prior to the change in circumstances.
