- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Employing firm when activities occurred which led to the complaint: CUSO FINANCIAL SERVICES, L.P.

Allegations: The client submitted a complaint in which she alleged that her conservative Orion managed account portfolio was unsuitable and requested return of her invested principal after realizing a short-term loss. CFS confirmed that its records reflect that proper risk disclosures were made to the client and that signed account documentation supported suitability for the fixed income managed portfolio recommendation. CFS determined that the managed portfolio had been negatively impacted by global economic events since purchase in November of 2021. Nonetheless, as a good faith gesture due to a potential misunderstanding, CFS is in the process of discussing settlement with the client for reimbursement of losses incurred.
