BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

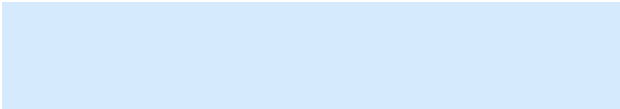

Broker Statement

THE FINANCIAL ADVISOR STATED THAT HE DID ENCOURAGE THE CLIENT TO STAY INVESTED AS THE INVESTMENTS WERE NOT FOR SHORT-TERM NEEDS, THEY WERE FOR THE LONG TERM. THE FINANCIAL ADVISOR WAS INSTRUCTED TO TRANSFER MONEY INTO AMERICAN FUNDS MONEY MARKET AND SINCE THE CLIENT WAS GOING TO STAY WITH AMERICAN FUNDS THEY WERE TOLD THEY COULD REINSTATE BACK INTO THE SAME FUND FAMILY ANY TIME. SINCE THE CLIENT WANTED TO GET INTO DIFFERENT FUNDS THERE WAS A 30 DAY WAITING PERIOD. THE FINANCIAL ADVISOR STATED THAT HE HAD VARIOUS CONVERSATIONS REGARDING DIVERSIFYING FURTHER FROM ICA AND THE CLIENT WAS NOT INTERESTED. AT ONE POINT THE CLIENT DID AGREE TO DIVERSIFY INTO THEIR FUNDS, HOWEVER, SEVERAL MONTHS LATER THE FINANCIAL ADVISOR WAS INSTRUCTED TO PLACE THE FUNDS BACK INTO ICA. IT WAS EXPLAINED THAT THE LOSSES EXPERIENCED IN THE ACCOUNT CAN BE ATTRIBUTED TO RECENT MARKET CONDITIONS AND NORMAL MARKET FLUCTUATION. CLAIM DENIED.
