BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at <https://www.adviserinfo.sec.gov>. - **Are there other resources I can use to check the background of investment professionals?**

THE IR STATED THAT THE ANNUITIES, WHICH WERE PURCHASED OUTSIDE OF EDWARD JONES, WERE TRANSFERRED IN TO THE CLIENT'S EDWARD JONES ACCOUNT, AT WHICH TIME THE CLIENT EXPRESSED A DESIRE TO MAKE CHANGES AS HE WAS DISSATISFIED WITH THE INVESTMENTS. THE IR EXPLAINED THAT THE ANNUITIES CARRIED A 14 YEAR SURRENDER SCHEDULE SO THERE WAS NOT MUCH THE IR COULD DO AT THAT TIME. THE IR STATED THAT THE CLIENT CONTACTED THE BRANCH SEVERAL TIMES AND WAS VERY INSISTENT ON MAKING CHANGES. AS A RESULT OF THE CLIENT'S PERSISTENCE, THE ANNUITY COMPANY WAS CONTACTED AND THE IR WAS TOLD THAT THE CLIENT COULD MAKE WITHDRAWALS OF 10% OF THE INITIAL PREMIUM, PENALTY FREE. THE CLIENT MADE FOUR WITHDRAWALS WITHIN APPROXIMATELY 2 YEARS. IT IS OUR OPINION THAT THE CLIENT INITIATED THE CHANGES IN THE ACCOUNT; THEY WERE NOT RECOMMENDED BY THE IR. AS JONES IR'S DO NOT OFFER TAX ADVICE, IT IS THE RESPONSIBILITY OF THE CLIENT TO CONSULT THEIR TAX PROFESSIONAL PRIOR TO MAKING ANY CHANGES THAT COULD RESULT IN A TAXABLE EVENT. IN ADDITION, THIS ACTIVITY WOULD HAVE BEEN REFLECTED ON THE CLIENT'S 2004 TAX RETURN AND THE WITHDRAWALS COULD HAVE BEEN STOPPED AT THAT TIME. BASED ON THE INFORMATION AVAILABLE IT IS OUR OPINION THAT THIS MATTER WAS NOT HANDLED IMPROPERLY BY THE IR OR EDWARD JONES. CLAIM DENIED.
