FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ACCORDING TO WARTSBAUGH, CUSTOMER'S 457 ACCOUNT WAS TO BE TRANSFERRED AND ADDED TO HIS EXISTING HARTFORD IRA. IT IS UNDERSTOOD, WHEN THE TRANSFER WAS COMPLETED IN APRIL, 2002, ALL FUNDS WERE ALLOCATED TO THE HARTFORD CAPITAL APPRECIATION FUND. WARTSBAUGH HAS INDICATED HE MET WITH THE CLIENTS AND CHANGES IN ALLOCATIONS WERE MADE TO THE FUNDS THROUGH EXCHANGES TO VARIOUS HARTFORD FUNDS. WARTSBAUGH HAS INDICATED NO MENTION WAS MADE OF INVESTING IN AMERICAN FUNDS AT THIS MEETING. WARTSBAUGH HAS STATED THE CLIENTS ESTABLISHED AN APPOINTMENT WITH HIM IN JULY, 2002 TO DISCUSS THEIR CONCERNS REGARDING THE DECLINE IN THE VALUE OF THE FUNDS. APPARENTLY, AT THIS MEETING, THE CLIENTS INQUIRED IF THEY WOULD BE ABLE TO PURCHASE AMERICAN FUNDS AT NET ASSET VALUE (NAV). APPARENTLY, WARTSBAUGH HAS STATED HE INFORMED THE CLIENT HE DIDN'T KNOW IF SHARES COULD BE PURCHASED AT NAV WITH AMERICAN FUNDS. HOWEVER, AFTER SOME INVESTIGATION, HE DISCOVERED PURCHASES OF AMERICAN FUNDS COULD BE MADE AT NAV. PAPERWORK WAS COMPLETED TO FACILITATE THE TRANSFER FROM HARTFORD TO EDWARD JONES AND AMERICAN FUNDS WERE PURCHASED IN CUSTOMER'S IRA ACCOUNT ON JULY 30, 2002 ACCORDING TO THE INSTRUCTIONS PROVIDED. BASED ON OUR REVIEW, PAPERWORK WOULD HAVE BEEN COMPLETED TO TRANSFER CUSTOMER'S 457 PLAN TO HIS EXISTING HARTFORD IRA ACCOUNT. IN ADDITION, THE CLIENT HAS RECEIVED STATEMENTS DIRECTLY FROM HARTFORD WHICH WOULD HAVE PROVIDED INFORMATION REGARDING THE INVESTMENTS HELD IN THE HARTFORD IRA ACCOUNT AS WELL AS REFLECTING ACCOUNT ACTIVITY (INCLUDING THE EXCHANGES). THEREFORE, IT IS OUR OPINION, THE TRANSFER AS WELL AS THE EXCHANGES WERE AUTHORIZED. IN REVIEWING ACCOUNT INFORMATION, IT APPEARS WARTSBAUGH REQUESTED CORRECTIONS TO THE TRANSACTIONS WHICH RESULTED IN A REIMBURSEMENT OF SALES CHARGES ASSOCIATED WITH THE HARTFORD FUNDS PURCHASE(S). BASED ON OUR REVIEW, WE WILL NOT BE MAKING ANY FURTHER ADJUSTMENTS IN REGARDS TO THIS SITUATION.
