BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. FORWARDED A COPY OF ONE OF THE NON-QUALIFIED FINANCIAL TRANSACTION FORMS USED IN PROCESSING THE WITHDRAWAL ON FEBRUARY 9, 2004 AND THIS FORM WAS SIGNED BY THE CLIENT ON JANUARY 22, 2004. THE FINANCIAL TRANSACTION FORM DOES INDICATE THAT ALL WITHDRAWALS BEFORE AGE 59 MAY BE SUBJECT TO A 10% IRS PENALTY AND THEY STRONGLY SUGGESTED THAT CLIENTS CONSULT THEIR OWN ATTORNEY, ACCOUNTANT OR TAX ADVISOR FOR INFORMATION. THE FA HAS STATED HE HAS ALWAYS INFORMED CLIENTS THAT HE CANNOT OFFER LEGAL OR ACCOUNTING ADVICE AND HE BELIEVED THIS CLIENT UNDERSTOOD THAT. ACCORDING TO STANDARD PROCEDURES, CLIENT WOULD HAVE RECEIVED 1099-R FORMS FROM ZURICH KEMPER IN JANUARY 2005 AND IT DOES NOT APPEAR CLIENT CONTACTED OUR FIRM REGARDING THESE TRANSACTIONS UNTIL JANUARY 2007. WHILE CLIENT WOULD HAVE BEEN TAXED ON THE DISTRIBUTIONS FROM THE ANNUITIES AT SOME POINT IN THE FUTURE, WE ARE OFFERING TO REIMBURSE THE 10% PENALTY ASSOCIATED WITH THE WITHDRAWALS.
