BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. IR INDICATED HE DISCUSSED SEVERAL OPTIONS WITH CLIENT, INCLUDING REMOVING PROCEEDS FROM THE ANNUITY AND PURCHASING MUTUAL FUNDS. ACCORDING TO IR, HE INDICATED TO THE CLIENT THAT THERE WOULD BE CAPITAL GAINS ON THE MOVE FROM THE ANNUITY AND INFORMED THE CLIENT THIS WOULD BE A TAXABLE EVENT. IN REVIEWING THE TRANSACTIONS, IT DOES NOT APPEAR THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT WERE OUTSIDE THE SCOPE OF THE INVESTMENT OBJECTIVES, AND BOTH THE CLIENT AND HEIRS MAY BENEFIT FROM THE TRANSACTIONS. IT IS OUR OPINION ALL TRANSACTIONS EFFECTED IN THE ACCOUNT WERE AUTHORIZED. HOWEVER, THE ACTUAL TAX LIABILITY MAY NOT HAVE BEEN VERIFIED BEFOREHAND, AND IT DOES NOT APPEAR THAT IT WAS SUGGESTED TO THE CLIENT TO CONSULT A TAX ADVISOR FOR ADVICE PRIOR TO THE TRANSACTIONS IN QUESTION OCCURRING. IN LIGHT OF THIS, THE FIRM MADE AN OFFER OF SETTLEMENT TO THE CLIENT IN THE AMOUNT OF \$4,000. THE CLIENT'S ATTORNEY AND THE FIRM ENGAGED IN SUBSEQUENT COUNTEROFFERS. THE FIRM EVENTUALLY RECEIVED CORRESPONDENCE FROM CLIENT'S ATTORNEY DATED JUNE 3, 2004, WHICH DECLINED THE FIRM'S FINAL OFFER OF \$5,000. THE FIRM CONSIDERS THIS MATTER CLOSED.
