FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

FINANCIAL ADVISOR WAS SELLING AGENT AND PRESENTED WITH ANNUITY PRODUCT ILLUSTRATION IN NOVEMBER 2007 PER REQUEST OF CLIENT FOR GUARANTEED RETURN AND GUARANTEE OF PRINCIPAL. CLIENT ENGAGED FINANCIAL ADVISOR AND COMPLETED APPLICATION IN JAN 2008. IN JULY 2008 CLIENT NOTICED THAT CONTRACT WRITTEN BY ANNUITY COMPANY DID NOT INCLUDE GUARANTEE OF PRINCIPAL AS APPLIED FOR AND CONTACTED FINANCIAL ADVISOR TO REMEDY. IN MAR 2009 CLIENT FILED COMPLAINT DUE TO INABILITY TO GET SATISFACTORY REMEDY FROM FINANCIAL ADVISOR, ALLEGING THAT BOTH THE FINANCIAL ADVISOR AND BANKING CLIENT MANAGER MISREPRESENTED THE PRODUCT FEATURES. THE BANKING CLIENT MANAGER WAS SOLELY INVOLVED IN THE INTRODUCTION OF THE CLIENT TO THE FINANCIAL ADVISOR AND HAD NO AUTHORITY OR ABILITY TO INFLUENCE THE FEATURES OF THE CONTRACT WITH THE CLIENT.
