- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: THE ALLEGATIONS ARE CONTAINED IN AN ELECTRONIC MAIL MESSAGE FROM THE CLIENT DATED MARCH 19, 2013, IN WHICH THE CLIENT SUGGESTS THAT FUNDS IN THE AMOUNT OF \$18,119.62 MAY HAVE BEEN MISAPPROPRIATED BY THE FIRM.

BY WAY OF BACKGROUND, ON OCTOBER 3, 2012, THE CLIENT SENT AN EMAIL MESSAGE TO THE REPRESENTATIVE INQUIRING ABOUT MOVEMENTS IN THE CLIENT'S INVESTMENT ACCOUNT WHICH OCCURRED DURING LATE AUGUST AND EARLY SEPTEMBER 2012. THE REPRESENTATIVE RESPONDED WITH A DETAILED EXPLANATION OF THE ACCOUNT MOVEMENTS. THE CLIENT DID NOT RESPOND TO THIS EXPLANATORY COMMUNICATION, AND IT WAS ASSUMED THAT THE CLIENT'S QUESTIONS AND CONCERNS HAD BEEN SUFFICIENTLY ADDRESSED. HOWEVER, APPROXIMATELY FIVE MONTHS LATER, THE CLIENT SENT THE EMAIL MESSAGE REFERENCED ABOVE TO A DIFFERENT REPRESENTATIVE OF THE FIRM, WHICH CONTAINS THE SUGGESTION OF MISAPPROPRIATION DISCLOSED IN THIS DRP. THE FIRM HAS INVESTIGATED THE MATTER, AND DETERMINED THAT NO MISAPPROPRIATION OCCURRED. THE MOVEMENTS IN THE CLIENT'S ACCOUNT ARE ATTRIBUTABLE TO MARKET MOVEMENTS, PURCHASES AND SALES INITIATED PURSUANT TO CLIENT INSTRUCTIONS, AND DEBIT AND

AS INDICATED ABOVE, THE MOVEMENTS IN THE CLIENT'S ACCOUNT ARE ATTRIBUTABLE TO MARKET MOVEMENTS, PURCHASES AND SALES INITIATED PURSUANT TO CLIENT INSTRUCTIONS, AND DEBIT AND CREDITS ATTRIBUTABLE TO TAX WITHHOLDING [AND VARIOUS MUTUAL FUND SALES CHARGES]. THE OBJECTIVE OF THE CONFERENCE CALL IS TO CLARIFY THE REFERENCED ACCOUNT MOVEMENTS AND TO CONFIRM, HOPEFULLY TO THE CLIENT'S SATISFACTION, THAT NO MISAPPROPRIATION OF THE FUNDS OCCURRED. STATUS AS OF 11/06/2013 ON APRIL 23RD, THE FIRM HAD A CONFERENCE CALL WITH THE CLIENT AND A DETAILED EXPLANATION OF THE ACCOUNT



MOVEMENTS WAS AGAIN PROVIDED TO THE CUSTOMER, DEMONSTRATING THAT NO MISAPPROPRIATION OCCURRED IN HIS ACCOUNT. IT IS OUR UNDERSTANDING FOLLOWING THIS CALL THAT THE CLIENT'S QUESTIONS AND CONCERNS HAVE BEEN FINALLY ADDRESSED TO THE CLIENT'S SATISFACTION. DURING THE CALL, THE CUSTOMER RECOGNIZED THAT HE NEVER PERFORMED A RECONCILIATION OF HIS BANK AND BROKERAGE ACCOUNTS AND, THEREFORE, REQUESTED ADDITIONAL ACCOUNT STATEMENTS, WHICH HAVE BEEN SUBMITTED TO HIM ALREADY. THE FIRM HAS NOT HEARD ANYTHING FURTHER FROM THE CLIENT AS OF TODAY WITH REGARDS TO SAID COMPLAINT.
