- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

Allegations: Without admitting or denying the findings, Castoriano consented to the sanctions and to the entry of findings that he exercised discretion in a customer account when executing transactions without written authorization from the customer or permission from his member firm. The findings stated that FINRA began investigating Castoriano after his firm filed a Form U5 reporting that he was permitted to resign in connection with exercising discretion without written trading authorizing in a client's account. Castoriano made the trades pursuant to an investment strategy agreed to with the customer. The customer complained to the firm about the trades and associated losses in his account. Without admitting liability, the firm settled the matter by paying the customer \$1,844.

THE CLIENT ALLEGED THAT TWO OF HIS CDS WERE NOT SOLD OUT OF HIS ACCOUNT IN A TIMELY MANNER AND, THEREFORE, CLIENT INCURRED AN ADDITIONAL \$86,000 IN TAXES. MY REVIEW INDICATED THAT THE CLIENT DID NOT HOLD ANY CDS WITH OUR FIRM, AND IN JUNE OF 2002, CLIENT GAVE INSTRUCTIONS TO LIQUIDATE HIS TOTAL ACCOUNT. THESE INSTRUCTIONS WERE GIVEN IN THE BRANCH OFFICE WITH A FIELD SUPERVISION DIRECTOR ON A CONFERENCE CALL WITH THE IR AND CLIENT. THE PROCEEDS FROM THIS SALE WERE ISSUED OUT TO THE CLIENT AT THE END OF JUNE 2002. IT COULD NOT BE DETERMINED HOW THE CLIENT MAY HAVE BEEN ASSESSED AN ADDITIONAL \$86,000 IN TAXES AS THE BONDS WERE SOLD AT APPROXIMATELY PAR AND THE MUTUAL



FUNDS WERE SOLD AT NAV. THE CLAIM WAS DENIED.
