- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

HOWEVER, CLIENT CLAIM THEY DID NOT AUTHORIZED THE LIQUIDATION OF AN ADDITIONAL \$71,000 OF BONDS ON 12/20. CLIENTS CLAIM THEY HAVE INCURRED LOSSES OF \$10,072 AS A RESULT OF THESE ADDITIONAL SELLS AS WELL AS LOST INCOME.

**Broker Statement**

OUR RECORDS REFLECT ORDERS TO LIQUIDATE THE BONDS WERE PLACED ON 12/19/07; HOWEVER, SOME OF THE BOND ORDERS DID NOT FILL UNTIL THE FOLLOWING DAY (12/20/07). FA STATED CLIENTS ORIGINALLY WANTED TO PURCHASE AN IMMEDIATE ANNUITY WITH NEW YORK LIFE AND HE EXPLAINED THE FEATURES OF AN IMMEDIATE ANNUITY. ACCORDING TO FA, CLIENTS EXPLAINED EXPENSES WERE INCREASING AND THEY NEEDED AN INCREASE IN INCOME. WHILE CLIENTS INITIALLY PROPOSED INVESTING \$100,000 INTO THE IMMEDIATE ANNUITY, FA SUGGESTED INVESTMENT PLAN INVESTING \$165,905 INTO AMERICAN FUNDS WITH SYSTEMATIC WITHDRAWALS. AFTER FURTHER DISCUSSION, FA ALTERED PROPOSAL AND SUGGESTED \$100,000 IN THE PROTECTIVE IMMEDIATE ANNUITY AND \$65,000 IN THE AMERICAN FUNDS. FA STATED CLIENTS AGREED WITH THIS PROPOSAL AND THE ORDERS WERE PLACED WITH CLIENTS' AUTHORIZATION. CLIENTS WOULD HAVE BEEN PROVIDED WITH TRADE CONFIRMATIONS REFLECTING ACTIVITY & PROSPECTUSES WOULD HAVE BEEN PROVIDED ON THE AMERICAN FUNDS PURCHASED. FURTHER, CLIENTS WOULD HAVE BEEN PROVIDED WITH THE CONTRACT AND PROSPECTUS ON THE IMMEDIATE ANNUITY. CUSTOMER STATEMENTS WOULD HAVE ADDITIONALLY BEEN PROVIDED REFLECTING ALL ACTIVITY IN ACCOUNT. IN ADDITION TO THE DOCUMENTS PROVIDED RELATED TO THE TRANSACTIONS, CLIENTS EXECUTED A B SHARE FUND PURCHASE ACKNOWLEDGMENT LETTER (COPY ENCLOSED) AS WELL AS A SWITCH ACKNOWLEDGMENT LETTER (COPY ENCLOSED) WHICH INDICATED CLIENTS WERE SELLING \$165,000 OF BONDS TO PURCHASE THE IMMEDIATE ANNUITY AND AMERICAN FUNDS. BASED ON OUR REVIEW, IT DOES APPEAR CLIENTS WERE AWARE \$165,000 WORTH OF BONDS (APPROX. \$175,000 FACE VALUE) WERE BEING LIQUIDATED FOR THE PURPOSE OF REINVESTING AS STATED ABOVE AND THE ACTIVITY WAS DONE WITH THEIR AUTHORIZATION AND SIGNED ACKNOWLEDGMENT. CLAIM DENIED.
