- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement CLIENT WAS A COLLEAGUE AND FRIEND WHO I WORKED WITH AT WELLS FARGO. SHE WANTED ME TO HELP HER CONSOLIDATE HER IRA FOR HER.



I DID HAVE A DETAILED DISCUSSION WITH HER ABOUT A SHARES, AND C SHARES AND THE DIFFERENT COST STRUCTURES EFFECTING BOTH SHARE CLASSES. WE DECIDED THAT A SHARES WOULD BE CHEAPER IN THE LONG RUN AND I WAS DIRECTED TO MAKE THE INVESTMENT. I ALSO DISCLOSED TO HER THAT I WOULD BE LEAVING WELLS FARGO SOON, AND SHE SAID IT WAS OK TO MAKE THE INVESTMENTS. THIS WAS DONE IN THE THIRD WEEK OF MARCH 2012. I SENT HER A HYPOTHETICAL AND A COMPREHENSIVE BREAKDOWN OF HER INVESTMENTS AND I HIGHLIGHTED THE UP-FRONT FEES AND THE ANNUAL INTERNAL EXPENSES. SHE FILED THIS COMPLAINT BECAUSE SHE DID NOT GET THE RIGHT FOLLOW-UP FROM WELLS FARGO. SHE WAS ALSO DISTRESSED ABOUT THE RECENT DOWN TURN IN THE MARKET IN THE MONTH OF MAY, WHICH WAS DOWN 10%. I HAVE SINCE SPOKEN TO HER AND SHE HAS APOLOGIZED TO ME AND HAS PLEDGED TO HELP GET THIS REMOVED FROM MY RECORD. IT ALSO MUST BE NOTED THAT I NEVER RECEIVED A COMMISSION ON THIS DEAL AND WELLS FARGO KEPT ALL THE COMMISSIONS AND THEN OFFERED NO SUPPORT, BECAUSE NO BROKER WAS ASSIGNED TO THE ACCOUNT AND NO ONE CALLED HER BACK TO EXPLAIN EVERYTHING.
